# Selecting a ProForm Order

Each transaction must be linked to a ProForm Order. If orders are currently open, the Active order will automatically be linked. If there aren't any open orders, the order number can be entered in the Selected order Number field of the Order Linking screen. Once the order is confirmed, click ok.

- **Price as Sold:** Field to enter the price the user sold the product to the customer by the user.
- **Suggested Retail Price:** The suggested price to be charged to the customer by the user.
- AIG Wholesale Cost: The price American Identity Group will charge the user.

## **Information Screen**

The **Information** screen allows the user to choose the individual the product is for by selecting a contact from the ProForm order by using the dropdown. To select an individual not listed in the ProForm order, users can select **Other** from the dropdown and manually enter the information.

- Account Holder Dropdown: Choose the contact from the ProForm order to be associated with the product.
  - Users can choose **Other** to manually enter the information of an individual who is not listed in the ProForm order.
- Address 1: The first address line for the chosen contact will be populated from the ProForm order. Field can be manually entered if Other is chosen from the dropdown. Field can be edited within the integration.

- **First Name:** The first name of the individual who will receive the monthly invoices.
- Last Name: The last name of the individual who will receive the monthly invoices.
- **Phone:** The phone number of the individual who will receive the monthly invoices.
- **Email:** The email of the individual who will receive the monthly invoices.
