Two new server pool settings added to the *SelectConfigDb.dbo.Settings* table.

To access these settings, open SoftPro Select Services and open the Properties dialog of a given mid-tier server instance. The new settings are visible and editable under the new category, **SQL Server Security**:

- Name: **Use Security Connection**, default value = **False**
- Name: **Trust SQL Server Certificate**, default value = **True**

Use Secure DB Connection	Trust SQL Server Certificate	Result (Encryption of data in-transit)
False (default)	Ignored	No encryption occurs.
True	False (default)	Data is encrypted, but a verifiable server certificate must be installed.
True	True	Data is encrypted and a self-signed server certificate may be used.

### Notes on Encryption and Certificates

If **Use Secure DB Connection** setting is set to **True** in the server settings, certificates are required. Traffic can be encrypted using self-signed certificates or certificates issued by a Certificate Authority. It is not recommended to use self-signed certificates in a production environment as those certificates are not as secure as certificates issued by a Certificate Authority. Customers are responsible for obtaining and managing the certificates on their servers.
