


- Support added to Select application for 360 Okta enhancement. 412665 / (v4.6.24)
- The client installer updated to use a new third-party tool, Velopack. 431115 / (v4.6.24)

The updated version prompt is still displayed when upgrading the client from an existing version of 4.6 to 4.6.24+.




Selecting **Yes**, displays a new second prompt citing **SoftPro Select is already installed**. This is a one-time prompt for the client update when upgrading from a version that used the Squirrel installer to the new Velopack installer.

Click **Repair** to perform the upgrade.



Once the upgrade completes successfully, the Select application can be used as normal.

The **Control Panel > Programs > Programs and Features** now shows **SoftPro Select** versus **SoftPro Select Client**. This is intentional with the Velopack client.

Select is configured to use these fixes by default. To turn these off when troubleshooting if issues are experienced, please note the following:

The configuration item is:

- Inside the **SoftPro.Select.Settings** section, **Configuration Name: UseLegacyAccessibilityFeatures**
- When this flag is set to **True** or absent: Memory fix is enabled; this is the default.
- When this flag is set to **False**: Memory fix is disabled; use for troubleshooting only.
